Introduction:

The Department of English, Kaliyaganj College in collaboration with the Department of English, University of Gour Banga, Malda, has decided to organize a one-day National Seminar on "Indian Writing in English: From Colonial to Global" on November 9, 2016. The seminar will be organized around plenary sessions and presentations by participants. Proposals for presentation at the conference are welcome from faculty members, research scholars and academicians engaged with research.

Concept Note:

Whether Indian writing in English in its primary sense should refer to the writings of Indians in English or writings in English within India has both fascinated and flummoxed critics for a long time. As such the expert opinion has oscillated between the journals and correspondences of Sir Thomas Roe, *The Embassy of Sir Thomas Roe to the Court of the Great Mogul, 1615-1619: As Narrated in His Journal and Correspondence* and the travel book by Sheikh Din Muhammad *The Travels of Dean Mahomet* in search of antecedents. A significant portion of predominantly urban Indian population learned English was to no small extent a result of the political ascendancy of the English in India. Macaulay's "Minute on Indian Education" and the English Education Act, 1835 greatly augmented not only English education but also expression in English (both verbal and written).

Indian writing in English began to play an ambivalent role as it at once helped perpetuate the colonial rule and subverted it through an effective mimicry, and in so doing facilitated the birth of Indian Nationalism. Traversing the phases of Postcolonial Literature specified by

Peter Barry namely the adopt, adapt and adept phases, Indian Writing in English in this post-globalized era can safely shed any consideration of the territorial space of India. In fact, the Indians working abroad and the Indian Diasporic communities are contributing significantly to the corpus of Indian writing in English today.

The objective of the proposed seminar is to trace the amazing simultaneity of stability and change that characterises Indian writing in English that has evolved negotiating the confusion of nomenclature, the variety of genres and themes, the influences of events and movements, the contribution of great thinkers and authors, and last but not least momentous changes in the spheres of politics, culture and society.
